### What our programmes offer attendees and their MATs:

We know that being in a leadership role in a MAT is rewarding, dynamic and challenging and we believe that colleagues in these roles benefit from the challenge and support of those who are in comparable roles in other MATS. Our experience tells us that colleagues can sometimes feel isolated in their roles and that peer networking and learning together can help improve motivation and sense of professional belonging.

We know there are some networks available to colleagues in Executive leadership roles already, but Inspiring Leaders believes our professional communities offer a more personalised leadership development opportunity and deeper opportunities for collaborative learning due to the regional location of our programme and the emphasis on face-to-face learning. "We have the most fantastic Chief Finance Officer in our MAT, but I worry that we are not investing in their development as much as we do for the teachers in our MAT. This could lead to us losing them, which would be a huge risk for our MAT."

## **Our Programmes**



### Our Professional Learning and Leadership Communities (PLLC) sessions detailed below are designed to support Trust Executive Leaders to:

- Develop their role specific knowledge by learning from colleagues in other MATs and from external sector experts
- Engage in meaningful peer support and challenge partnerships, in order to be reflective about their practice and that of others
- Creating strategy, empowering and enabling others, creating alignment, personal leadership behaviours, creating vision, leading with courage and empathy, and wider leadership development.
- Working with colleagues in other MATs to develop practice and policy together, learning and benefiting from those around them.
- Help colleagues to understand how to be more impactful in their roles.

In all our programmes there will be an opportunity for learners to influence the content so that we are tailoring our approach to their needs. This will be balanced with some fixed features of the programme to ensure a consistency in experiences for colleagues in your MAT. Inspiring Leaders is passionate about the power of research and how this should inform practice and will underpin all our learning with relevant academia.

Our carefully planned programme will take place over four half day sessions per year and will be facilitated by colleagues at Inspiring Leaders. Learners will be required to engage in some light touch pre and post session activities to fully engage in the learning experience. Where possible all sessions will take place face to face in order to maximise the opportunity for learners to work closely with other colleagues.

## **Programme Facilitators**

#### Our programmes are facilitated by experienced school and MAT leaders who have a passion for developing leaders.

Each of our communities will have a lead facilitator who will oversee the learning experience and activities of the group. In addition, we will call upon external experts and leaders from within the group to showcase expertise and examples of practice.

The learning experience of each group will be tailored to its needs. There will be an expectation that leaders attending our sessions are active participants and have an openness to learning and collaborating.

In this PLLC we will bring together colleagues responsible for educational outcomes for pupils in their MAT to explore a range of key strategic areas of responsibility which will include:



### **New Developments for MATs**

#### **MAT Reviews**

From September 2022 we will be offering MATs the opportunity to take part in a MAT peer review programme. The details of the programme are currently in development, but we expect this process to support CEOs in the development of their MATs practice, along with supporting them to report back on their effectiveness to their Trustees. MAT reviews can be helpful to support a cycle of continuous improvement and help prepare for a future MAT Inspection.



#### MAT Improvement capacity
